Approved market members are entitled to sell online all year through the Statesboro Market2Go, to participate in scheduled Saturday markets at fees to be announced; and to have priority for a booth at the annual Shopping by Lantern Light event.
The MainStreet Farmers market will reopen Saturday, April 2, at the new facility behind the Convention and Visitors
Bureau, and operate there each Saturday morning, from 9:00 to 12:30, through November 19.
