2024 MARKET SEASON BOOTH RATES

The MainStreet Farmers market will reopen **Saturday, April 6, 2024,** at the venue directly behind Visit Statesboro, and will operate every Saturday morning, from 9:00am to 12:30pm, weekly through November 23, 2024.

NOTE:

Vendors who wish to attend **Opening Day 2024 on April 6**must register no later than March 30, 2024.

Schedule changes must be made <u>at least 1 week in advance</u>, unless prior approval is obtained. Vendors will receive a credit on their account for any rescheduled markets. Vendors who cancel <u>less than 1 week in advance</u> will be charged the weekly booth fee associated with their assigned space. Once a tier has been selected, the Vendor will be assigned this space for the remainder of the season, unless alternate requests are made and approved. Any requests to be moved to an alternate location or a different tier (i.e. Indoor to Outdoor) must be made <u>at least 1 week in advance</u>.
